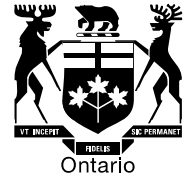

This letter acknowledges receipt of your application for renewal of natural gas marketer licence. The Board has assigned File Number EB-2007-0621 to this matter. Please refer to this number in all future correspondence to the Board regarding this matter.

Your application is currently incomplete and cannot be processed until the following has been filed:

1. Licence GM-2002-0313 is issued to Superior Propane Inc. and this application is to renew this licence under the name of Superior Energy Management, a Division of Superior Plus LP. For Board records, a short explanation for the name change is required.
2. What is the communication plan to inform customers under contract/ agreement with Superior Propane Inc. of the licence name change?

For your information, the Board issues a licence under the legal name of the business entity. The legal name is Superior Plus LP and the licence name request is Superior Energy Management, a Division of Superior Plus LP. To accommodate this, an acceptable licence name is Superior Plus LP dba Superior Energy Management, a Division of Superior Plus LP.

The Board records show that Licence GM-2002-0313 issued to Superior Propane Inc. will be expiring on June 26, 2007. An option available is an interim order to extend this licence until such time that there is a decision date for your renewal application. If you wish to have this licence extended, please submit a written request to the Board.

The Board will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the Board may close the file for this application.

Upon receipt of the required information the Board will issue an acknowledgement letter indicating the expected date on which a decision and/or order may be rendered.
