INTERVENTION OF ENBRIDGE GAS DISTRIBUTION INC.

1. Enbridge Gas Distribution Inc. ("Enbridge" or the "Company") hereby applies for intervenor status in this proceeding pursuant to the above-captioned matters.
2. Enbridge is a distributor, transmitter and storage provider of natural gas in Ontario. The supply, transmission and distribution and storage of natural gas within Ontario are all of vital concern to the Company and its customers.
3. Enbridge has a direct interest in all matters of jurisdiction, substance, and procedure in the regulation of public utilities, and in any decision of the Ontario Energy Board (the "Board"), which may create a precedent affecting the Company's own applications.
4. Enbridge purchases certain storage and transportation services from Union Gas Limited ("Union") pursuant to rate schedules approved by the Board.
5. Enbridge undertakes and delivers demand side management programs. Some of these programs have been and may be delivered in future jointly, together with and/or pursuant to inputs and assumptions developed together with Union Gas Limited ("Union"). This proceeding involves the consideration by the Board of the 2015 to 2020 Multi-year Demand Side Management Plans of both Enbridge and Union. As such, Enbridge has an interest in all aspects of this proceeding, future requirements, and the treatment of related costs for ratemaking purposes.

6. Enbridge reserves the right to be heard in English, to appear by or with counsel of its choice, to cross-examine on all subject matters in this hearing that may relate to its interests, to adduce evidence on specific matters that are relevant to these proceedings, and to present argument.
