**Union Gas Limited**  
**Quarterly Rate Adjustment Mechanism ("QRAM") of July 1, 2008**

I am writing on behalf of our client, Canadian Manufacturers & Exporters ("CME"). We have reviewed the QRAM Application of Union Gas Limited ("Union") seeking to change the rates and other charges to reflect increases in gas supply commodity, gas supply transportation and delivery rates effective July 1, 2008.

CME sought one clarification from Union with respect to the rate change occurring in the delivery price adjustment for sales rates. Union has satisfactorily responded to CME's clarification request. CME is satisfied with the material filed by Union in support of its QRAM Application.

Approximately 85% of CME's 1,200 Ontario-based member companies are Small to Medium size business Enterprises ("SMEs") with 500 employees or less. For this reason, CME's review of Union's QRAM Application has primarily focused on the rate classes which serve SMEs.

CME is a not-for-profit organization funded by membership fees and revenues from services it renders to the Federal and Provincial Governments and agencies to foster the development of national and international markets for its members and to break down trade barriers. CME's ability to review QRAM Applications, as it has done in this case, is dependent upon a determination that it is eligible for a cost award.

CME requests that the Board award it its reasonably incurred costs in conducting its review of Union's QRAM Application. We will submit a claim for costs on behalf of CME if the Board responds favourably to this request.
