Environmental Defence seeks intervenor status and costs eligibility as a leading environmental organization that represents both the public interest in environmental protection and the interests of consumers whose energy bills can be reduced through increased conservation and other means.

#### **Environmental Defence**

Environmental Defence is a frequent intervenor at the Ontario Energy Board and has filed an Annual Information Filing for frequent intervenors. Environmental Defence wishes to address whether the DSM plans are consistent with the Minister of Energy's binding directive dated March 26, 2014, requiring the achievement of all cost-effective DSM.
