# NOTICE OF APPLICATION AND WRITTEN HEARING

# Onit Energy Ltd. Applications for Electricity Retailer and Gas Marketer Licence

## The Applications

Onit Energy Ltd. filed two applications on April 16, 2015 with the Ontario Energy Board (the "OEB") under section 60 and section 50 of the *Ontario Energy Board Act, 1998,* (the "Act") for an Electricity Retailer licence and a Gas Marketer licence, respectively. The granting of these licences would enable the applicant to retail electricity and market natural gas in Ontario.

The applications will be decided by an employee of the OEB who has been delegated this authority pursuant to section 6 of the Act. The OEB does not intend to provide for an award of costs when deciding the applications.

## How to see the Applications

## How to Participate

Interested persons may participate in the Board's hearing of the applications by following the steps set out in this notice.

## Oral vs. Written Hearings

There are two types of OEB hearings – oral and written. The OEB intends to proceed with these applications by way of a written hearing. If you think an oral hearing is needed, you can write to the OEB to explain why. Your submission must be received by the OEB and copied to Onit Energy Ltd. by **May 21, 2015.** 

## Interrogatories

If you wish to obtain information from the applicant that is in addition to the application materials already filed with the OEB (i.e. the "pre-filed evidence") and that is relevant to the hearing, you must request it by written interrogatories filed with the OEB, and delivered to the applicant, on or before **June 4, 2015**. Please ensure that each interrogatory request includes a reference to the relevant page or item in the pre-filed evidence.

The applicant shall file complete responses to each interrogatory with the OEB, and deliver them to all interested parties in the proceeding, no later than **June 18, 2015**.

## Written Submissions

You may express your views on the applications by filing a written submission with the OEB. Your submission must be received by the OEB and copied to Onit Energy Ltd. by **July 9, 2015.** 

If Onit Energy Ltd. wishes to respond to any submissions, its reply shall be made in writing, and filed with the OEB and copied to any party who made a written submission by **July 21, 2015.** 

All written submissions sent to the OEB will be placed on the public record, which means that the written submissions will be available for viewing at the OEB's offices and will be placed on the OEB's website. If the written submission is from a private citizen, the OEB will remove any personal (i.e., not business) contact information from the written submission (e.g., the address, phone number, and e-mail address of the individual), before placing the written submission on the public record. However, the name of the individual and the content of the written submission will become part of the public record.

As stated elsewhere in this notice, you must provide a complete copy of your written submission (including your name, contact information, and everything written in the submission) to the applicant.

## How to File Documents with the Board

All written submissions filed with the OEB must quote file numbers EB-2015-0157/EB-2015-0158 and clearly state the sender's name, postal address, telephone number and email address. You must forward two paper copies and, if possible, an electronic copy in Word format and in searchable PDF format, of your written submission to the OEB and one copy to the applicant. All written submissions to the OEB should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
