Re: EB-2014-0101: Oshawa PUC Networks Inc. (OPUCN) 2015-2019 Rates.

Request for Extension of Time to File Interrogatory Reponses.

Procedural Order No. 1 herein directs that OPUCN file responses to interrogatories by tomorrow, May 5th. On behalf of OPUCN we write to request a brief extension of time within which to complete this filing.

Board Staff filed its interrogatories for OPUCN on April 16th. OPUCN appreciates that Energy Probe filed its interrogatories early on April 15th, and SEC filed its interrogatories early on April 17th. On or about April 20th OPUCN received interrogatories from CCC, GOCC, and VECC.

In aggregate, OPUCN has received approximately 300 interrogatories, most of them with multiple separate questions on a given topic, resulting in more than 1000 questions. Many of these questions seek comprehensive updated data and multi-step analyses.

OPUCN continues to work diligently on responding to all interrogatories. With a limited staff, OPUCN requires a few more days to complete this process, and ensure that all questions are answered and properly cross-referenced to each other and to the comprehensive application filed with the Board.

OPUCN believes that it will be able to file complete responses to all interrogatories no later than this Friday, May 8th.

The next step in the process directed in P.O. No. 1 is for Staff to determine if a technical conference is required, and if so for parties to notify OPUCN of the topic areas that they intend to explore at the technical conference. That notification from parties is scheduled to be provided by May 15th, for a technical conference that would begin on May 20th.

Should the brief delay in OPUCN's interrogatory response filing necessitate that parties be provided with additional time to review those interrogatory responses and provide notification to

OPUCN of topics that they intend to explore at a technical conference, OPUCN believes that it can accommodate a delay in such notification until the end of the day on May 18th.

Subject to this slight adjustment, it does not appear that OPUCN's request for a brief delay in filing interrogatory responses would otherwise disrupt the schedule set out in P.O. No. 1.

We appreciate the Board's consideration of this request.
