We are writing on behalf of the Universities Group of Southwestern Ontario (UGSWO) to seek intervenor status and cost award eligibility in this proceeding.

1. Universities Group of Southwestern Ontario (UGSWO) and its Interest in this Proceeding

UGSWO represents the collective interest of the six universities that are in the Union South franchise area and its main goal is to collaboratively assist its member universities with the management and control of natural gas costs.

The UGSWO members receive regulated natural gas services from Union Gas Limited primarily under Rates M1, M2, M4, M5 and M7. UGSWO wishes to intervene in this proceeding because the issues, methodologies and impacts raised by the application may result in contractual changes to Direct Purchase customers on an ongoing forward basis.

UGSWO intends to actively participate in this proceeding for the purpose of ensuring the record in this proceeding is complete and that all relevant facts are placed in evidence for the Board's consideration. UGSWO intends to make submissions on the issues which are raised in this application, including:

- The appropriateness of the balances in the Deferral and variance accounts and their allocation to the various rate classes;
- ii. The appropriateness of the request to recover costs applicable to winter 2014/2015 spot variances for the month of March 2015;
- iii. The appropriateness of the new Deferral Account Union is asking the Board to approve and;
- iv. Any other issues that may be raised in the application or arise throughout the proceeding.

2. Cost Award

UGSWO intends to seek a cost award in the proceeding on the grounds that its ability to participate is dependent upon a determination that it is eligible for such an award. UGSWO believes it is eligible to apply for a cost award based on Section 3.03(a) of the Practice Direction on Cost Awards and hereby requests the Board's determination of such cost eligibility

E2 Energy Inc. represents UGSWO under the auspices of a written retainer agreement executed on behalf of each the member universities.
