**Union Gas Limited and Enbridge Gas Distribution Inc.**

**Joint application for approval of new  
and updated conservation measures.**

**PROCEDURAL ORDER NO. 1  
May 11, 2015**

Union Gas Limited (Union) and Enbridge Gas Distribution Inc. (Enbridge) filed a joint application with the Ontario Energy Board (OEB) on March 27, 2015 seeking approval for new and updated conservation measures. The OEB requires the gas utilities to annually update the assumptions that are used to determine savings for a list of Demand Side Management (DSM) measures and has encouraged the utilities to file a joint application.

The application is made to update the common Table of Measure Assumptions and Substantiation Documents. The application includes new and updated measures, and the current approved measures assumptions. The Technical Evaluation Committee supports the updates to the specific measure assumptions as set out in the application.

The OEB issued a Notice on April 16, 2015. The following parties applied for intervenor status and cost eligibility:

- Building Owners and Managers Association, Greater Toronto (BOMA)
- Canadian Manufacturers & Exporters (CME)
- Green Energy Coalition (GEC)

I grant each of BOMA, CME, and GEC intervenor status and have determined that they are each eligible to apply for an award of costs under the OEB's *Practice Direction on*

*Cost Awards.* Appendix A attached to this Procedural Order provides the contact information for the parties in this proceeding.

I consider it necessary to make provision for the following matters related to this proceeding. Provision is being made for written submissions following the filing of interrogatory responses, unless the OEB orders otherwise during the course of the proceeding. The OEB may issue further procedural orders from time to time.

**THE BOARD ORDERS THAT:**

1. OEB staff and intervenors shall request any information and material from Union and Enbridge that is in addition to Union and Enbridge's evidence, and that is relevant to the hearing, by written interrogatories filed with the OEB and copied to Union and Enbridge by **May 26, 2015**.
2. Union and Enbridge shall file with the OEB complete written responses to the interrogatories and copy intervenors by **June 9, 2015**.
3. Unless the OEB orders otherwise, OEB staff and intervenors wishing to file a written submission shall do so by **June 23, 2015**. Any submission should be filed with the OEB and copied to Union and Enbridge and intervenor(s).
4. Unless the OEB orders otherwise, Union and Enbridge may file a written reply submission with the OEB, and copy it to intervenors by **July 8, 2015**.

All filings to the OEB must quote the file number, EB-2014-0354 and be made electronically through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/> in searchable / unrestricted PDF format. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
