Suncor Energy Products Inc.

**Application to determine the location of electricity
distribution facilities within road allowances owned by
the County of Lambton**

PROCEDURAL ORDER NO. 4

June 5, 2015

Suncor Energy Products Inc. (Suncor) filed an application with the Ontario Energy Board (OEB) on November 25, 2014, under subsection 41(9) of the *Electricity Act*, 1998, S.O. 1998, c. 15, Schedule A, as amended (Electricity Act) for an order or orders establishing the location of Suncor's proposed distribution facilities within certain road allowances owned by the County of Lambton (County) because Suncor and the County had not been able to agree on the location of these distribution facilities.

On April 30, 2015, the County filed a letter with the OEB requesting that the OEB "defer from making any ruling until after a Council County meeting scheduled for June 3, 2015." In the same letter, the County further pledged to inform the OEB and Suncor of the outcome of County Council deliberation no later than June 4, 2015.

The OEB approved the County's request and made provisions in Procedural Order No. 3, issued on May 15, 2015, for the filing of any update respecting this matter.

The OEB received a letter from the County on June 3, 2015 indicating that the County Council approved a Road Use Agreement between Suncor and the County and that execution of this agreement will take approximately a week.

In light of this development, the OEB suspends the timetable for the filing of submissions and reply submissions set out in Procedural Order No. 3, and asks that the parties inform the OEB whether a disagreement in respect of this matter remains.

The OEB considers it necessary to make provision for the following matters related to this proceeding.

IT IS THEREFORE ORDERED THAT:

1. The County and Suncor shall file a status update and indicate whether or not there remains a disagreement respecting the location of Suncor's facilities within the County's road allowances on or before **June 15, 2015**.
2. The timetable for the filing of submissions and reply submissions set out in Procedural Order No. 3 is suspended pending further directions from the OEB.

All filings to the OEB must quote the file number, EB-2014-0355 and be made electronically in searchable/unrestricted PDF format through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
