**Union Gas Limited**

**Application for leave to construct three natural gas  
pipelines to serve a mine site and the City of Greater  
Sudbury.**

**PROCEDURAL ORDER NO. 2**

**June 8, 2015**

Union Gas Limited (Union) filed an application with the Ontario Energy Board (OEB) on March 11, 2015 for approval to construct three separate natural gas pipelines each approximately two kilometers in length to serve a new mine site and to meet the growing demands for natural gas in the City of Greater Sudbury. The application was made under section 90 of the *Ontario Energy Board Act, 1998*.

The total capital cost of the proposed facilities is estimated to be \$10.8 million. The pipeline to the mine site involves a capital contribution from the mining company.

Energy Probe Research Foundation (Energy Probe) and Industrial Gas Users Association (IGUA) requested and were granted intervenor status.

IGUA's letter of intervention dated April 20, 2015 requested that the OEB defer its determination of whether an oral hearing is needed. IGUA left open the possibility that it may file evidence later in the proceeding pending Union's responses to the interrogatories. On June 4, 2015, IGUA filed a letter saying it would not be seeking to file evidence but that it would like the opportunity to make a brief submission.

Procedural Order No. 1 established a process limited to the filing of interrogatories and Union's responses by May 27, 2015.

In view of IGUA's letter of June 4, 2015, the OEB will proceed with a written process for the filing of submissions and a reply.

The OEB may issue further procedural orders from time to time.

**THE OEB ORDERS THAT:**

1. OEB staff and intervenors shall file any written submissions with the OEB and copy Union by **June 22, 2015**.
2. Union shall file any written reply submission with the OEB and deliver it to the intervenors by **June 30, 2015**.

All filings to the OEB must quote the file number, EB-2015-0120 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
