AND IN THE MATTER OF an application pursuant to section 74 of the *Ontario Energy Board Act, 1998* by Hydro One Networks Inc. and Veridian Connections Inc. seeking an order to amend their current Electricity Distribution Licences (ED-2003-0043 and ED-2002-0503 respectively);

AND IN THE MATTER OF an application pursuant to section 86(1)(b) of the *Ontario Energy Board Act, 1998* by Hydro One Networks Inc. seeking an order granting leave to sell distribution assets necessary in serving the public to Veridian Connections Inc.

DECISION AND ORDER June 11, 2015

THE APPLICATION

Hydro One Networks Inc. (Hydro One) and Veridian Connections Inc. (Veridian) filed a joint application with the Ontario Energy Board (OEB) on March 24, 2015 under sections 74 and 86(1)(b) of the *Ontario Energy Board Act, 1998* (OEB Act). The application seeks an order of the OEB to amend the applicants' licensed distribution service areas and to approve the sale of distribution assets necessary in serving the public from Hydro One to Veridian.

The OEB issued its Notice of Application and Written Hearing on April 10, 2015. The notice was served by Hydro One upon the customers located on the lands that are the subject of the service area amendment application. No customers responded to the Notice of Application and Written Hearing.

The lands that are the subject of the service area amendment are described in Appendix A to this Decision and Order.

The application addresses the long term load transfer (LTLT) arrangement between Veridian and Hydro One. A long term load transfer is a situation in which a customer is within one distributor's service area but is actually served electricity from a second distributor. In this case, Veridian is the physical distributor (i.e., provides the physical delivery of electricity to the customers) while Hydro One is the geographic distributor (i.e., licensed to serve the customers).

Section 6.5.4 of the OEB's Distribution System Code requires geographic distributors to eliminate LTLT arrangements by either negotiating the transfer of the customers to the physical distributor or by the geographic distributor extending its system to connect the customers.

The proposed service area amendments would transfer 41 customers, who are currently connected to Veridian's distribution system but are located within Hydro One's licensed service area to Veridian's licensed service area. Presently, the 41 customers are considered Hydro One customers. After the amendment, these customers will be billed and otherwise served by Veridian as Veridian customers. The application states that the proposed service area amendment would have no impact on Hydro One's licence, as Hydro One's service area in the Municipality of Clarington includes all areas with the exception of that served by Veridian.

The assets proposed to be sold by Hydro One to Veridian in this transaction include a number of poles, transformers and a switch as described in the application. These assets serve and will continue to serve the transferred customers.

FINDINGS

The service area amendment is prompted by the OEB's policy that requires the elimination of long term load transfers. The application is consistent with OEB policy.

The applicants stated that the proposed service area amendment is the most costeffective approach for eliminating the subject LTLT arrangement. The applicants further
stated that it would not be economical and cost effective for Hydro One to expand its
distribution system to connect the these customers. According to the application,
safety, reliability and service quality will not be affected. The current distribution rates
for the customers being transferred from Hydro One to Veridian will be lower as a result
of the service area amendment.

In relation to the sale of the distribution assets from Hydro One to Veridian, the application stated that Hydro One's distribution assets are currently used and will continue to be used to service the customers to be transferred to Veridian. The sale price for the assets proposed to be sold by Hydro One to Veridian represents the net book value of the assets.

I find that it is in the public interest to amend Schedule 1 of Veridian's electricity distribution licence to reflect the transfer of the 41 customers from Hydro One to Veridian. I also find that it is in the public interest to grant Hydro One leave to sell the assets described above to Veridian.

IT IS THEREFORE ORDERED THAT:

- Veridian Connections Inc.'s electricity distribution licence (ED-2002-0503), specifically Schedule 1 of the licence, is amended to include the lands described in Appendix A to this Decision and Order.
- 2. Hydro One Networks Inc. is granted leave to sell the assets described above.
