



**EB-2014-0101**

**IN THE MATTER OF** the *Ontario Energy Board Act*, 1998, S.O. 1998, c. 15, (Schedule B);

**AND IN THE MATTER OF** an application by Oshawa PUC Networks Inc. for an order approving just and reasonable rates and other charges for electricity distribution to be effective January 1, 2015 and for each following year through to December 31, 2019.

**PROCEDURAL ORDER NO. 4**  
**June 16, 2015**

Oshawa PUC Networks Inc. (Oshawa PUC) filed a custom incentive rate-setting application with the Ontario Energy Board (OEB or Board) on January 29, 2015 under section 78 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to the rates that Oshawa PUC charges for electricity distribution, to be effective January 1, 2015 and each year thereafter until December 31, 2019.

The OEB issued a Notice of Application and Hearing on February 18, 2015. On March 20, 2015, the OEB issued Procedural Order No. 1 in which it approved the intervention and cost eligibility status of five parties. Procedural Order No. 2 was issued on May 6, 2015 which amended the dates for certain procedural steps.

A Settlement Conference was held on June 2, 3 and 4, 2015. Parties were unable to come to an agreement.

On June 9, 2015 Oshawa PUC filed a letter on behalf of all parties indicating that certain issues on the Board approved issues list could be heard in writing.

The Board accepts the parties' submission and agrees that the issues listed in the letter will be heard in writing. The remaining issues will be decided through an oral hearing.

**THE BOARD ORDERS THAT:**

1. The oral hearing for this proceeding will begin on **Tuesday, June 30, 2015** at the OEB's hearing room at 2300 Yonge Street, 25th floor at 9:30 a.m., and continue on **Thursday July 2** and **Friday July 3, 2015** if necessary.
2. The Board panel will reconvene to hear argument in chief from the applicant on **Wednesday July 8, 2015 at 12:30 p.m.** On **Thursday July 9, 2015**, beginning at 9:30 a.m. the panel will hear Board staff and any intervenor who chooses to present oral argument.
3. Those intervenors who choose to file written argument must file that argument with the OEB and copy it to all parties no later than **Wednesday July 15, 2015**.
4. Reply argument from Oshawa PUC must be filed with the OEB and copied to all parties no later than **Friday July 24, 2015**.

All filings to the OEB must quote the file number, EB-2014-0101, be made in searchable / unrestricted PDF format electronically through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed at the Board's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
