### **SUPPLEMENTAL DECISION AND ORDER ON COST AWARDS**

In a letter dated June 12, 2015, the Board gave notice to rate-regulated distributors and transmitters that in its [March 20, 2015](#) Decision and Order on Cost Awards in relation to the Low-Income Assistance Strategy Review, it inadvertently had not considered a second cost claim submitted by the Low Income Energy Network (LIEN).

LIEN's cost claim, in the amount of \$8,250.00, for the services of a consultant, was submitted on November 14, 2014, before the Board issued the Notice of Hearing for Cost Awards on February 4, 2015, and was not served on distributors and transmitters.

In its June 12, 2015 letter, the Board invited distributors and transmitters to file any objections to LIEN's claim by June 22, 2015. The letter advised them that if no objections were filed the Board would award the costs requested by LIEN, apportioned between them in the same manner as in the March 20, 2015 cost order (i.e., 75% to distributors and 25% to transmitters, and within each class, based on distribution or transmission revenues, as applicable).

No objections have been filed. The Board therefore awards the full amount requested

by LIEN, apportioned on the basis of the March 20, 2015 cost order. The amount payable by each distributor and transmitter is listed in Appendix A.

### **Process for Paying the Cost Awards**

The Board will use the process set out in section 12 of the Practice Direction to implement the payment of the cost awards. Therefore, the Board will act as a clearing house for all payments of cost awards relating to this consultation process. Invoices will be issued to distributors and transmitters at the same time as invoices for cost assessments made under section 26 of the Act. The practice of the Board is to issue to each distributor and transmitter one invoice that covers all cost awards payable by the distributor and transmitter for the relevant period. As a result, the invoice may cover cost awards payable in relation to a number of consultations, including this one.

### **THE BOARD THEREFORE ORDERS THAT:**

1. The electricity distributors and transmitters listed in Appendix A shall pay the costs awarded to LIEN as set out in Appendix A.
2. Payment shall be made to the Ontario Energy Board in accordance with the invoice issued to each distributor and transmitter, and shall be due at the same time as cost assessments under section 26 of the *Ontario Energy Board Act, 1998* are due.
