DECISION AND ORDER ON COST AWARDS
June 23, 2015

BACKGROUND

On April 3, 2014, the Ontario Energy Board (OEB) issued a letter regarding its draft Policy on Rate Design for Electricity Distributors. The OEB has now released its Policy on Rate Design for Electricity Residential Customers.

In its April 3, 2014 letter, the OEB indicated that cost awards would be available to eligible persons under section 30 of the *Ontario Energy OEB Act, 1998* (the Act) in relation to their participation in cost eligible activities, and that costs awarded, as well as any OEB costs, will be recovered from all rate-regulated electricity distributors apportioned on a pro-rata basis relative to their contributions to the Board's annual cost assessment.

Eligible Participants and Eligible Activities

In its Decision on Cost Eligibility dated May 29, 2014, the Board determined that the following participants are eligible for an award of costs in relation to their participation in one or more of the consultation activities:

- Association of Major Power Consumers in Ontario (AMPCO)
- Association of Power Producers of Ontario (APPPrO)
- Building Owners and Managers Association (BOMA)
- Canadian Manufacturers & Exporters (CME)
- Canadian Solar Energy Association (CanSIA)
- Consumers Council of Canada (CCC)
- Energy Probe Research Foundation (Energy Probe)
- Green Energy Coalition (GEC)
- London Property Management Association (LPMA)
- Low-income Energy Network (LIEN)
- School Energy Coalition (SEC)
- Sustainable Infrastructure Alliance of Ontario (SIA)
- Vulnerable Energy Consumers Coalition (VECC)

On April 30, 2015, the Board issued a Notice of Hearing for Cost Awards in relation to this consultation process (the Notice). The Notice indicated that cost awards would be available for: (i) preparing written comments in response to the Board's draft Policy, up to a maximum of 25 hours; and (ii) preparation for, attendance at and reporting on stakeholder meetings held with staff May 16, 2014 or May 26, 2014, to a maximum of 7 hours.

AMPCO, APPPrO, BOMA, CME, CanSIA, Energy Probe, GEC, LPMA, LIEN, SEC, SIA and VECC submitted cost claims. No objections to these filed cost claims were received.

OEB Findings on the Cost Claims of the Eligible Participants

The cost claims filed by the eligible participants are in accordance with Notice with the exception of BOMA. The OEB notes that the cost claim filed by BOMA contains hours that exceed the maximum number of hours set out in the Notice. The Board will therefore reduce BOMA's claim to the stipulated maximum of 25 hours. BOMA's cost claim also requires a reduction of \$1,337.96 due to double HST charged on the "Summary of Fees and Disbursement Being Claimed" form.

The claims of VECC and LIEN require a reduction to correct a calculation error.

The claim of APPrO requires a reduction of \$1,118.70 to appropriately reflect the correct tariff for a consultant. APPrO applied an incorrect tariff for its consultant (i.e., the claim for consultant was placed in the 20+ year category when it should have properly been placed in the 11 to 19 year category).

For the same reason noted above for APPrO, the claim of CanSIA requires a reduction of \$915.30 to appropriately reflect the correct tariff for the consultant.

The OEB finds that the claims of AMPCO, CME, CCC, Energy Probe, GEC, LPMA, SEC and SIA and the adjusted claims of APPrO, BOMA, CanSIA, LIEN and VECC are entitled to 100% of their reasonably incurred costs of participating in this consultation.

The amount payable by each individual rate-regulated distributor in relation to costs awarded to each eligible participant is listed in Appendix A to this Decision and Order.

Process for Paying the Cost Awards

The OEB will use the process set out in section 12 of the *Practice Direction on Cost Awards* to implement the payment of the cost awards. Therefore, the OEB will act as a clearing house for all payments of cost awards relating to this proceeding. Invoices will be issued to all rate-regulated electricity at the same time as invoices for cost assessments are made under section 26 of the Act. The practice of the OEB is to issue to each rate-regulated electricity distributor one invoice that covers all cost awards

payable by that distributor for the relevant period. As a result, the invoice may cover cost awards payable in relation to a number of consultations, including this one.

THE BOARD THEREFORE ORDERS THAT:

1. The amounts to be paid by each rate-regulated electricity distributor in relation to the costs awarded to each eligible participant are as set out in Appendix A to this Decision and Order.
2. The rate-regulated electricity distributors listed in Appendix A to this Decision and Order shall pay the costs awarded to each of the eligible participants as set out in Appendix A.
3. The rate-regulated electricity distributors listed in Appendix A to this Decision and Order shall pay the OEB's costs of, and incidental to, this consultation.
4. Payment of cost awards and of the OEB's costs referred to in paragraphs 2 and 3 shall be made to the OEB in accordance with the invoice issued to each rate-regulated electricity distributor, and shall be due at the same time as cost assessments under section 26 of the Act are due.
