The Ontario Energy Board (OEB) has now issued its Notice of Hearing for Union's application for its NEXUS Long-Term Contract (Notice). The Notice will be published by the OEB, in accordance with directions to the OEB's agent which has been copied to you. Please note that you must comply with the directions in paragraphs 1 and 2 below **prior to July 12, 2015** which is the publication date of the newspaper in which the Notice will appear last. If you are unable to comply with the directions within this timeframe, you must inform the Board Secretary immediately.

You are directed:

1. No later than the date the Notice is posted on Union's website in accordance with paragraph 2, to arrange for the service of each of the enclosed English and French Notices, in the exact form accompanying this letter, together with the application and the evidence, directly on the Clerks of all municipalities in which Union supplies gas, all First Nation Bands and First Nation Reserves to which Union supplies gas, the Métis Nation of Ontario, Enbridge Gas Distribution Inc., Natural Resource Gas Limited, Kitchener Utilities, and all intervenors in Union's 2015 rates proceeding EB-2014-0271 and Union's 2014 ESM and deferral account clearance proceeding EB-2015-0010.

2. To make a copy of the Notice, the application and evidence, and any amendments thereto, available for public review at Union's office and in a prominent place on Union's website.
3. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 1 and 2 above immediately thereafter.
4. To provide a copy of the Notice, application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
