**B2M Limited Partnership
Application for an order approving a just and
reasonable revenue requirement for electricity
transmission to be effective January 1, 2015 through
to December 31, 2019.**

**PROCEDURAL ORDER NO. 2
July 2, 2015**

B2M Limited Partnership (B2M LP) filed an application with the Ontario Energy Board (OEB) on March 30, 2015 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to its electricity transmission revenue requirement for 5 years from 2015 to 2019, to be effective January 1, 2015 and each year thereafter to December 31, 2019.

The OEB issued Procedural Order No. 1 on May 27, 2015, setting dates for interrogatories and other procedural steps. B2M LP filed interrogatory responses on June 29, 2015.

Further Procedural Steps

The OEB finds that a transcribed technical conference would assist in this proceeding.

IT IS THEREFORE ORDERED THAT:

1. A transcribed Technical Conference will be held **July 16, 2015** starting at 9:30 a.m. in the OEB's offices at 2300 Yonge Street, 25th floor, Toronto, Ontario to clarify any matters arising from the interrogatory responses. Parties intending to participate are to notify B2M LP, and copy all parties, of the topic areas for questioning by **July 13, 2015**.

2. OEB staff shall file a proposed issues list agreed to by all parties and OEB staff, or, alternatively, shall advise the OEB in writing that the parties and OEB staff have been unable to reach an agreement on a draft issues list, by **July 17, 2015**.

All filings to the OEB must quote the file number, EB-2015-0026 and be made in searchable / unrestricted PDF format electronically through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed at the Board's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
