LETTER OF DIRECTION

Please also note that the Notice will also be published in Le Weekender by the OEB, in accordance with directions to the OEB's agent. The information about this publication was previously provided to you.

2. No later than the date the Notice is posted on Hearst Power's website in accordance with paragraph 3, to arrange for the service of the enclosed English version of the Notice, in the exact form accompanying this letter and the application and the evidence, directly on all intervenors of record in Hearst Power's previous cost of service rate proceeding EB-2009-0266, namely:

Vulnerable Energy Consumers Coalition.

3. To make a copy of both the English and French versions of the Notice, the application and evidence, and any amendments thereto, available for public review at Hearst Power's office and in a prominent place on Hearst Power's website.
4. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 1, 2 and 3 above immediately thereafter.
5. To provide a copy of the Notice, application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
