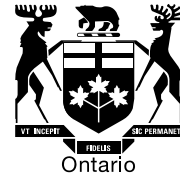

LETTER OF DIRECTION

Dear Mr. Maxim:

**Re: NOVA Chemicals Canada (NOVA Chemicals)
Kimball Pipeline Replacement Project
Ontario Energy Board File Number: EB-2015-0212**

The Ontario Energy Board (OEB) has now issued its Notice of Hearing (Notice) for NOVA Chemicals' application for the Kimball Pipeline Replacement Project. The Notice has been published by the OEB in accordance with directions to the OEB's agent. Please note that you must comply with the directions in paragraphs 2 and 3 below **prior to August 14, 2015.**

If you are unable to comply with the directions within this timeframe, you must inform the Board Secretary immediately.

You are directed:

1. If you have not already done so, to conduct a search of title forthwith, sufficient to determine the current registered property owners and encumbrancers with lands or interest in the lands directly affected by the proposed pipeline and related facilities.

2. No later than the date the Notice is posted on NOVA Chemicals' website in accordance with paragraph 3, to arrange for the service personally, by courier or by registered mail of the enclosed Notice, in the exact form accompanying this letter and the application directly on each of the following:
 - a. all property owners and encumbrancers with lands or interest in lands identified in the search of title referred to in paragraph 1 above
 - b. the clerks of the affected municipalities
 - c. all aboriginal communities that have been consulted or with lands or interest in the lands directly affected by the proposed pipeline and related facilities
 - d. the Métis Nations of Ontario, Lands, Resources and Consultation Office, 75 Sherbourne St., Suite 222, Toronto, Ontario M5A 2P9
 - e. all affected utilities and railway companies
 - f. members of the Ontario Pipeline Coordinating Committee
3. To make a copy of the Notice, the application and evidence, and any amendments thereto, available for public review at NOVA Chemicals' office and in a prominent place on NOVA Chemicals' website.
4. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 1, 2 and 3 above, immediately thereafter.
5. To provide a copy of the Notice, application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
