Union Gas Limited

Application for pre-approval of the recovery of the cost consequences associated with the installation of three new compressors along Union's Dawn to Parkway pipeline transmission system.

PROCEDURAL ORDER NO. 1 August 11, 2015

Union Gas Limited (Union) filed an application with the Ontario Energy Board (OEB) on June 30, 2015 pursuant to section 36 of the *Ontario Energy Board Act, 1998*, for pre-approval of the recovery of the cost consequences associated with the installation of three new compressors and associated facilities on the Dawn-Parkway transmission system. The total estimated cost of the project is \$622.5 million.

A Notice was issued on July 21, 2015 and was served and posted as per the direction of the OEB.

A late intervention request was filed by the Vulnerable Energy Consumers Coalition (VECC).

Each of APPrO, BOMA, Energy Probe, FRPO, IGUA, LPMA, VECC and SEC also applied for cost award eligibility. No objections were received regarding the requests for intervenor status or cost eligibility.

I hereby grant intervenor status to each of the parties listed above and find that each of APPrO, BOMA, Energy Probe, FRPO, IGUA, LPMA, VECC and SEC is eligible to apply for an award of costs under the OEB's *Practice Direction on Cost Awards*. The list of intervenors in this proceeding is attached as Schedule A to this procedural order.

I consider it necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

1. OEB staff and intervenors that require information and material from Union that is in addition to Union's evidence and that is relevant to the hearing, shall request it by written interrogatories filed with the OEB and delivered to Union and the intervenors by **August 21, 2015**.
2. Union shall file with the OEB complete responses to the interrogatories and deliver them to the intervenors by **September 11, 2015**.

All filings to the OEB must quote the file number, EB-2015-0200 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. If the web portal is not available parties may email their documents to the address below.
