**PROCEDURAL ORDER NO. 1
August 13, 2015**

Natural Resource Gas (NRG) filed an Application on July 9, 2015 with the Ontario Energy Board (OEB) under section 36 of the *Ontario Energy Board Act, 1998*, for an order of the Board approving rates for the distribution of natural gas and other charges for 2015 (fiscal year 2016) based on the Incentive Ratemaking framework approved by the OEB, effective October 1, 2015.

A Notice was issued on July 29, 2015 and was published and served as per the direction of the OEB.

Union Gas Limited (Union) was the only company that filed an intervention request. No objections were received regarding the request for intervenor status.

I hereby grant intervenor status to Union, the information for which is attached as Schedule A to this procedural order.

I consider it necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

1. Union and OEB staff who wish information and material from NRG that is in addition to the evidence filed with the OEB, and that is relevant to this proceeding, shall request it by written interrogatories filed with the OEB and delivered to NRG by **Tuesday, August 18, 2015**.

2. NRG shall file with the OEB complete responses to the interrogatories and deliver them to Union by **Friday, August 21, 2015**.
3. Unless the OEB orders otherwise, Union and OEB staff who wish to make a written submission must file their submissions with the OEB and deliver them to NRG by **Tuesday, August 25, 2015**.
4. Unless the OEB orders otherwise, NRG shall file a written reply submission with the OEB and deliver it to Union by **Thursday, August 27, 2015**.

All filings to the OEB must quote the file number, **EB-2015-0115** and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.

All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
