**Application for the Classification of Certain
Natural Gas Pipelines**

**PROCEDURAL ORDER NO. 1
August 13, 2015**

Tribute Resources Inc. (Tribute) applied on June 22, 2015 to the Ontario Energy Board under section 25(3) of the *Assessment Act* to the Ontario Energy Board (OEB) for an order that certain natural gas pipelines owned by Tribute in Norfolk County, the Municipality of Bayham, and the Municipality of Malahide are not gas transmission pipelines and were not gas transmission pipelines at any time from and after January 1, 2012.

A Notice of Hearing was issued on July 10, 2015 and was posted and served as per the direction of the OEB.

Municipal Property Assessment Corporation (MPAC) applied for intervenor status. Tribute did not file any objection.

I hereby grant intervenor status to MPAC. The list of parties in this proceeding is attached as Schedule A to this Procedural Order.

I consider it necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

1. If OEB staff and MPAC require information and material from Tribute that is in addition to Tribute's evidence and that is relevant to the hearing, they shall request it by written interrogatories filed with the OEB and serve them on Tribute by **August 25, 2015**.

2. Tribute shall file with the OEB complete responses to the interrogatories and serve them on MPAC by **September 4, 2015**.
3. If MPAC wishes to present evidence it shall file that evidence with the OEB and serve it on Tribute by **September 15, 2015**.
4. If OEB staff and Tribute require information and material related to MPAC evidence, that is in addition to the evidence filed and is relevant to the hearing, they shall request it by written interrogatories filed with the OEB and served them on MPAC by **September 25, 2015**.
5. MPAC shall file with the OEB complete responses to the interrogatories serve them on Tribute by **October 6, 2015**.
6. Unless the OEB orders otherwise, MPAC and OEB staff may file any written submission with the Board and serve it on Tribute by **October 20, 2015**.
7. Unless the OEB orders otherwise, Tribute may file a written reply submission with the OEB and serve it on MPAC by **November 2, 2015**.

All filings to the Board must quote the file number, EB-2015-0206 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
