"He's quite keen to come and discuss some of his previous work in environmental law," said the coalition's Dale Mackenzie. "He's worked quite closely with biologists and has been quite active in the environmental area. I expect he'll have an interesting perspective that will be very on-topic for this area."

The coalition formed in 2008 in an effort to prevent logging activities on the Farabout Peninsula. They have since succeeded in having the area removed from the harvest plan until

This summer the Coalition has embarked on trying to set a tone for responsible stewardship of the lake environment with the

introduction of their Eagle Lake Environmental Code — a set of common sense guidelines based on a similar code from New Zealand.

"We started to distribute them to some of the tourist camps out there and the reaction has been positive,' said Mackenzie. "For the most part I think people are pretty careful about their lunch sites around the lake. but it's just something we saw as being positive and constructive. They are only guidelines, but it's a reminder when you go out berry picking, pleasure riding, or hiking or whatever, that people care, that people are watching what goes on out there."

**Protect Water Birds** 

Our water birds are in decline. Boats and sea-doos can help protect water birds by reducing speed and wake along shorelines, especially during nesting and when birds have young.

Consider others




If you write a letter of comment, your name and the content of your letter will be put on the public record and the OEB website. However, your personal telephone number, home address and e-mail address will be removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.

This hearing will be held under section 36 of the Ontario Energy Board Act, 1998, S.O. 1998 c.15 (Schedule B).



## **Independent Forest Audit of the Wabigoon Forest**

Ontario legislation governing sustainable forest management requires an Independent Forest Audit (IFA) of each Sustainable Forest License (SFL) or Crown Management Unit in the Province every five years. The Forestry Futures Trust Committee has retained Arbex Forest Resource Consultants Ltd. to conduct an Independent Forest Audit of the Wabigoon Forest for 2010-2015 audit term. The Forest is managed by Domtar Inc. under the authority of SFL # 541953 and administered by the Ontario Ministry of Natural Resources and Forestry (OMNRF) Dryden District Office. The audit will assess the forest management activities of Domtar and the OMNRF.
