

# Mother of shooting victim says son didn't deserve to die

The mother of a Brampton man and Malton street gang member who was fatally gunned down outside Muzik nightclub earlier last week says she is trying to understand how her son met such a violent death.

"No one deserves to die this way, under any circumstances," Auline Lewis, mother of 23-year-old shooting victim Duvel Hibbert, said in a statement yesterday. "As a family, we're struggling to understand what happened at the club that night, and how our son could die so tragically."

Hibbert and Ariela Navarro-Fenoy, 26, of Toronto, were killed when someone fired multiple gunshots inside and outside Muzik nightclub around 3:30 a.m. Aug. 4. Hibbert was found dead inside the club. Navarro-Fenoy was found outside, according to Toronto police. Three others were wounded.

Hibbert, who was before the courts on drug charges and had a lengthy criminal record that included

gun crimes, was "an intended target," Toronto Police Chief Mark Saunders said, adding that Navarro-Fenoy was an innocent bystander who "was not involved in any way in any altercation."

Saunders wouldn't comment on reports that Hibbert was set to testify in an upcoming murder trial or was seen as a police "snitch" who was spotted by other clubgoers.

In her statement, Lewis, a developmental services worker in Brampton, says her son lived with her and, before his death, had been planning to move to Windsor with his girlfriend to make a new life.

Originally from England, Duvel came to Canada when he was four years old and still has relatives living there. Many are planning to attend his funeral on Aug. 29.

Saunders revealed there are two suspects being sought. The event was the official after party for rapper Drake's OVO Fest.

Toronto police are asking anyone with video from the incident to upload it to the Toronto police website.

## ONTARIO ENERGY BOARD NOTICE TO CUSTOMERS OF UNION GAS LIMITED

Union Gas Limited has applied for approval to change its gas commodity, storage and transportation rates effective January 1, 2016.

Union Gas Limited has applied to change its rates to better reflect how it supplies natural gas to its customers. The proposed changes include the following:

- A change in the reference price used to set rates on a quarterly basis for a majority of its customers; and
- A change to how it allocates costs to the different types of customers that it serves.

An average residential customer would see the following annual bill impact, but these impacts would only start in 2018:

Residential Customer – Service Area	Approximate Bill Impact
Southern Ontario (Windsor to Hamilton)	Decrease of \$20
Northern Delivery Area	Increase of \$26
(North Bay to Kapuskasing)	
All Other Delivery Areas	Decrease of \$1.50 – \$51.50

The Ontario Energy Board (OEB) will hold a public hearing to consider the application filed by Union Gas.

We will question Union Gas on the case. We will also hear arguments from individuals and from groups that represent the customers of Union Gas. At the end of this hearing, the OEB will decide whether to approve the changes that Union Gas has requested in this application.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

### BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- You can review the application filed by Union Gas on the OEB's website now.
- You can file a letter with your comments, which will be considered during the hearing.
- You can become an active participant (called an intervenor). Apply by **August 25, 2015** or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- At the end of the process, you can review the OEB's decision and its reasons on our website.

### ORAL VS. WRITTEN HEARINGS

There are two types of OEB hearings – oral and written. The OEB will determine at a later date whether to proceed by way of a written or oral hearing. If you think an oral hearing is needed, you can write to the OEB to explain why by **August 25, 2015**.

### PRIVACY

If you write a letter of comment, your name and the content of your letter will be put on the public record and the OEB website. However, your personal telephone number, home address and e-mail address will be removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.

This hearing will be held under section 36 of the Ontario Energy Board Act, 1998, S.O. 1998 c.15 (Schedule B).
