Ruscio said he has faith in Duane Moleni, the recently minted association general manager, hired in April.

However, one lingering bone of contention between the Downtown Association and those who looked to repeal the bylaw deals with expanding the BIA outside its existing zone.

Moleni told The Sault Star Thursday he doesn't necessarily dismiss moving outside the six current blocks, but believes applying change to the present jurisdiction first, and determining its effectiveness, is most prudent

in proving the BIA area works.

This remains unacceptable to Ruscio and others.

You have an association called the Downtown Association," he added. "Downtown Association just does cover what they do and what they want to do. And that was part of our arguments from the beginning.
"We still think there is no voice

of downtown."

In fact, Ruscio doesn't dismiss further efforts to repeal the bylaw should such concerns continue to fall on deaf ears. The association, Ruscio argues, flip-flopped on this issue recently, as it had agreed previously the down-town is "much broader" than six

"Now, at the last minute, they've pulled that back and said they just want to play with Queen Street," Ruscio said.

A repeat repeal drive is not something anyone wants - nor believes will have to be carried out, Ruscio said

"This was very long and drawn out," he added. "But I don't think we're going to have to go that route. This new group, if they are what they say ... all eyes are on them now. Had the decision been to

repeal, the city clerk's office would have prepared a report to council, which would have had until the end of the year to repeal

The fact the focus is often on

the Downtown Association itself, and not the "old and antiquated" bylaw that governs it, is "terrible,"

Ruscio said. "And that's all we were trying to change," he added. "We were told

you can't and, absolutely, you can. You can amend it. You can disband it. They have the option of disbanding it and changing it. The city has the option of disbanding it and changing it. We only have the option of talking to them and, or trying to abolish.

"But I think now we are talking. We are today where we wish we would have been six months ago. I'm quite happy with the results."

# Ex-preem subject of sex lawsuit

TORONTO - A manager with the Pan and Parapan American Games alleges in a lawsuit that she was sexually harassed by David Peterson, the former Ontario premier and TO2015 In a statement of claim filed

with the Ontario Superior Court, Ximena Morris, 34, further alleges that when she complained to human resources and senior officials, she was first told to "let it roll off your back" and then

None of the allegations have been proven in court.

The claim alleges a history of flirtatious remarks from Peterson that escalated into unwanted hugs, sexually tinged remarks and public humiliation.

"'Hello Beautiful' was Mr. Peterson's common greeting, evolving to more aggressive and suggestive language," the claim

At an April 2014 event, the statement of claim alleges, Peterson "without invitation or consent reached and violated the physical and sexual integrity of Ms. Morris by embracing her, touching his chest to her breast, commenting again about her physical attributes

The claim also alleges a "concerned and embarrassed" Saad Rafi, TO2015's CEO, turned to Morris at one point and told her: "Please don't sue us; let it roll off your back." Morris also names the Pan and

Parapan Am Games organizing committee, the Canadian Olympic Committee (a partner of the Games) and three members of the executive team at TO2015. She is seeking \$10 million in damages.

"I deny the allegations, categorically, and look forward to confronting them in court," Peterson said in an email. Neala Barton, TO2015's vice-
