DECISION AND ORDER

Union Gas Limited ("Union") filed an application dated April 9, 2008 with the Ontario Energy Board (the "Board") under section 8 of the *Municipal Franchises Act*, R.S.O. 1990, c. M.55, as amended (the "Act"), for an order of the Board superseding those parts of an existing Certificate of Public Convenience and Necessity (E.B.C. 29) relating to the former Village of Chatsworth, the former Township of Holland and the former Township of Sullivan now within the Township of Chatsworth and replacing them with a single Certificate of Public Convenience and Necessity for the amalgamated Corporation of the Township of Chatsworth. The Board has assigned file number EB-2008-0081 to this application.

The Board's Notice of Application and Written Hearing was published on April 25, 2008. There were no intervenors. Union has a Certificate of Public Convenience and Necessity (E.B.C. 29) granting Union the right to construct works to supply natural gas to 25 municipalities. The former Village of Chatsworth, the former Township of Holland and the former Township of Sullivan were three of these municipalities. On January 1, 2000, the former Village of Chatsworth, the former Township of Holland and the former Township of Sullivan were amalgamated to form the Township of Chatsworth.

The Board finds that it is in the public interest to grant the application and that public convenience and necessity requires that approval be given.

IT IS THEREFORE ORDERED THAT:

- 1. The Certificate of Public Convenience and Necessity attached as Appendix A to this Decision and Order replaces those parts of Certificate E.B.C. 29 relating to the former Village of Chatsworth, the former Township of Holland and the former Township of Sullivan.
- 2. The Certificate of Public Convenience and Necessity, attached as Appendix A to this Decision and Order, is granted to Union Gas Limited to construct works to supply gas in the Township of Chatsworth.
