**AND IN THE MATTER OF** an application by Union Gas Limited for an Order pursuant to section 99(5) of the Act granting authority to expropriate certain interests in land for the purposes of constructing, operating and maintaining a natural gas pipeline and ancillary facilities in the City of Hamilton, the City of Burlington, and the Town of Milton.

#### AFFIDAVIT OF SERVICE

I, Jonathan Myers, of the City of Vaughan, in the Province of Ontario, MAKE OATH AND SAY:

- 1. I am Counsel at Torys LLP and am counsel of record to Union Gas Limited ("Union") in respect of its application to the Ontario Energy Board (the "Board") for authority to expropriate certain interests in certain interests in land for the purposes of constructing, operating and maintaining a natural gas pipeline and ancillary facilities in the City of Hamilton, the City of Burlington, and the Town of Milton (EB-2015-0230). In this capacity, I have been responsible for overseeing service and publication of the Notice of Application that was issued on August 18, 2015 by the Board (the "Notice") and, as such, have personal knowledge of the matters herein deposed.
- 2. Further to Section 1 of the Board's Letter of Direction dated August 18, 2015 (the "Letter"), I can confirm that on August 24, 2015 searches of title were carried out by Torys LLP to confirm the current registered property owners and encumbrancers with lands or interests in lands directly affected by the expropriation application.
- 3. Further to each of the sections marked as Section 2 in the Letter (note there was a numbering error in the Letter), I can confirm that on August 24, 2015 the date "September 8, 2015" was inserted into the relevant places of the Notice and a copy of the Dated Notice was filed with the Board.
- 4. Further to Section 3 of the Letter, I oversaw and arranged for the Dated Notice (a copy of which is included as **Exhibit 'A'** hereto), together with the corresponding application, evidence, property descriptions, aerial maps and survey plans showing the details of the proposed expropriations (as filed with the Board on July 20, 2015) to be served by courier or registered mail on all parties identified in Appendix C of the application (as amended by correspondence filed on behalf of Union dated July 24, 2015, August 6,

2015 and August 12, 2015) which were confirmed by search of title to include all persons identified as having a direct or registered interest in the lands directly affected by the expropriation application, all of which is evidenced by the post office registration and courier receipts attached as **Exhibit 'B'** hereto. Service was effected prior to the date that the Dated Notice was posted on Union's website.

5. Further to Section 4 of the Letter, I can confirm that Union has made copies of the Dated Notice, as well as the non-confidential version of the application and evidence, available for public review at its offices and in a prominent place on its website as of August 27, 2015.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

#### BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- You can review the application filed by Union on the OEB's website now.
- · You can file a letter with your comments, which will be considered during the hearing.
- You can become an active participant (called an intervenor). Apply by September 8, 2015 or the
  hearing will go ahead without you and you will not receive any further notice of the proceeding.
- At the end of the process, you can review the OEB's decision and its reasons on our website.
