

LETTER OF DIRECTION

Dear Mr. Wachsmuth:

**Re: Union Gas Limited
2016 Storage Enhancement Project
Board File Number EB-2015-0250**

The Ontario Energy Board (OEB) has now issued its Notice of Hearing (Notice) on Union Gas Limited's application for approval of the 2016 Storage Enhancement Project. Please note that you must serve the Notice on the parties identified below **within fourteen days** of the date of this letter. If service is not possible within fourteen days, you must inform the Board Secretary immediately.

You are directed:

1. To conduct a search of title forthwith, sufficient to determine the current registered property owners and encumbrancers with lands or interest in lands within the Designated Storage Areas of the storage pools that are the subject of this application.
2. To remove from the Notice both occurrences of the bold and bracketed words "[insert actual date 10 calendar days from the date the notice is posted on the applicant's website]" which are found in the sections entitled "**BE INFORMED AND HAVE YOUR SAY**" and "**ORAL VS. WRITTEN HEARINGS**" and insert the date which shall be determined by adding 10 calendar days to the date that the Notice will be posted on Union

Gas Limited's website in accordance with the requirements of paragraph 5 below. If that date falls on a "holiday" as defined in Rule 6.02 of the OEB's *Rules of Practice and Procedure*, insert the next date that is not a holiday. Use the following date format "**January 1, 2014**".

3. Once the the requirements of paragraph 2 are completed, to immediately and prior to completing any other steps required in this letter of direction, file with the OEB a pdf version of the complete (dated) Notice (Dated Notice).
4. No later than the date the Dated Notice is posted on Union Gas Limited's website in accordance with paragraph 5, to personally serve a copy of the Dated Notice, the application and the evidence, on:
 - a. All landowners identified through the search of title directed to be conducted in paragraph 1 above;
 - b. All owners and operators of rail lines, telecommunications (e.g. telephone) or other utilities within the Designated Storage Areas of the storage pools that are the subject of this application;
 - c. The Clerks of the Township of Dawn, the Township of Enniskillen, the Township of Plympton, the City of Sarnia and Lambton County; and
 - d. The Ministry of Natural Resources and Forestry, Petroleum Operations Section, London Ontario.
5. To make copy of the Dated Notice, the application and the evidence, and any amendments thereto, available for public review at Union Gas Limited's office and in a prominent place on Union Gas Limited's website.
6. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 4 and 5 above immediately thereafter.

You are further directed not to include any documents or materials when serving the Dated Notice other than documents or materials expressly required by this letter of direction to be served.
