The Building Owners and Managers Association, Greater Toronto (BOMA) seeks intervenor status and cost award eligibility in the above noted proceeding. levels of government providing a voice for Commercial Property owners in the Greater Toronto Area and throughout Ontario.

As a representative of a large sector of energy consumers in the Greater Toronto Area and throughout Ontario, the commercial and industrial building owners and generators, BOMA seeks a cost award in this proceeding.

BOMA plans to participate actively in this proceeding, to submit interrogatories, cross-examine Enbridge's witnesses and submit argument. It will focus on project need, cost estimates and economics, cost recovery arrangements, the proposed deferral and variance account, and related matters.
