ONTARIO ENERGY BOARD IN THE MATTER OF the Ontario Energy Board Act, R.S.O. 1980, c. 332 and, in particular, section 24(c) thereof; AND IN THE MATTER OF an application by The Consumers' Gas Company Ltd., Pembina Exploration Limited and 691923 Ontario Ltd. for an Order requiring and regulating the joining of various interests within a field or pool in the Township of Mersea, County of Essex known as the Hillman Pool, for the purpose of drilling or operating wells, the designation of management and the apportionment of the costs and the benefits of such drilling or operation.

APPLICATION

1.	The Consumers' Gas Company Ltd., Pembina Exploration Limited and 691923 Ontario Limited hereby apply to the Ontario Energy Board, pursuant to the provisions of the Ontario Energy Board Act, R.S.O. 1980, c. 332, for an Order:	6
(a)	fixing the area hereinafter described, and known as the Hillman Pool, as an area subject to unitization;	7
(b)	joining and regulating the interests of all owners and encumbrancers of the lands within the Hillman Pool in accordance with the terms and conditions of the draft Lease Amendment Agreement attached as Appendix "A" to this application, or in accordance with such other terms and conditions as the Board may deem appropriate;	8
(c)	designating The Consumers' Gas Company Ltd. as the manager and operator of the said Pool;	9
(d)	providing that the Order shall terminate when all of the recoverable oil and gas reserves have been produced from the said Pool;	10
(e)	fixing the effective date of the Order as April 1, 1987;	11

(f)	fixing such other terms and conditions as the Board may deem necessary or appropriate in order to effectively unitize the said Pool.	13

2.	The Hillman Pool is an oil field located in the Township of Mersea, in the County of Essex, east of the Town of Learnington. It is approximately \neg mile wide by over 2 miles long and is found at a depth of approximately 2600 feet in Ordovician age rock.	14
3.	The recoverable oil reserves in the Hillman Pool are estimated to be in the order of 1 000,000 barrels. As at the date of this application, production from the Pool exceeds 700 barrels of oil per day. The Pool also contains natural gas, but in quantities which do not currently justify production.	15
4.	The Hillman Pool was discovered by means of seismic surveys which were conducted between 1980 and 1982. A discovery well was drilled in 1983 and further seismic surveys and drilling operations were conducted between 1984 and 1987 in order to delineate the extent of the Pool.	16
5.	A diagram showing the lands comprising the area proposed for unitization is attached as Appendix "B" to this application. A legal description of the lands comprising the area proposed for unitization is attached as Appendix "C" to this application. A list of the registered owners of the lands within the proposed unit is attached as Appendix "D" to this application.	17

6. All of the landowners listed in Appendix "D" have entered into oil and gas leases covering the lands which they own within the area proposed for unitization. These leases are all currently held by The Consumers' Gas Company Ltd. or by Pembina Exploration Limited.

- 7. 691923 Ontario Ltd. (a company affiliated with Devran Petroleum Ltd.) owns a working interest in the lands comprising the area proposed for unitization by reason of a joint venture with Consumers'. No one other than the applicants holds a working interest in such lands. Pembina and 691923 Ontario Ltd. have agreed that Consumers' should be the manager and operator of the pool.
- 8. Lease Amendment Agreements similar in form to Appendix "A" hereto have been entered into with all of the landowners set out in Appendix "D", except:
