Enbridge Gas Distribution Inc.

**Application for leave to construct a natural gas pipeline
in the Towns of Deep River and Laurentian Hills in
Renfrew County**

**PROCEDURAL ORDER NO. 1
September 11, 2015**

Enbridge Gas Distribution Inc. (Enbridge) applied on June 30, 2015 to the Ontario Energy Board (OEB) for an order for leave to construct a natural gas pipeline and ancillary facilities to provide service to the Canadian Nuclear Laboratory Chalk River Facility (CNL) which is located in the Town of Laurentian Hills, County of Renfrew (Pipeline Project). The proposed route for the Pipeline Project is in the Towns of Deep River and Laurentian Hills.

A Notice was issued on August 11, 2015 and was served and published as directed.

CNL applied for intervenor status. Enbridge did not file any objection.

I hereby grant intervenor status to CNL. The list of parties in this proceeding is attached as Schedule A to this Procedural Order.

I consider it necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

1. If OEB staff and CNL require information and material from Enbridge that is in addition to Enbridge's evidence and that is relevant to the hearing, they shall request it by written interrogatories filed with the OEB and delivered to Enbridge by **September 18, 2015**.
2. Enbridge shall file with the OEB complete responses to the interrogatories by **September 25, 2015**.

3. Unless the OEB orders otherwise, OEB staff and CNL may file any written submission with the OEB and deliver it to Enbridge by **October 2, 2015**.
4. Unless the OEB orders otherwise, Enbridge may file a written reply submission with the OEB by **October 9, 2015**.

All filings to the Board must quote the file number, EB-2015-0194 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address, telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
