Greetings, this email is in response to Martha McOuat's questions regarding Hydro One Brampton's 2016 IRM application Rate Generator model requiring an immediate response to her email below. We have reproduced her questions below and provided an answer:

• Hydro One Brampton to review the entry in the 2012 Board-approved disposition column of Sheet 3 of the model and confirm any adjustment required.

Hydro One Brampton confirms that an adjustment is required for the "*Board-approved disposition during 2012*" column to transfer \$98,295 to the "*Transactions Debit/(Credit) during 2012 excluding interest and adjustments*" column. The value of \$97,294 reported in the "Disposition and Recovery/Refund of Regulatory Balances (2011)" row should be adjusted to (\$1,001).

• Hydro One Brampton to review the consumption data for the Distributed Generation class on Sheet 9 of the model and report to Board staff the adjustments required to ensure that these kWh are not double-counted.

Hydro One Brampton conducted a review as requested by Board Staff and reports that an adjustment is required on "Sheet 9. RTSR Current Rates" in the "Non-Loss Adjusted Metered kWh for the General Service Less Than 50kW Service Classification" column for both rows 19 and 20.

The kWh value reported for row "Retail Transmission Rate - Network Service Rate" was 331,606,198 kWh and this value should be adjusted to 331,492,483 kWh so the value reported for the Distributed Generation Service Classification of 113,715 kWh is not double-counted.

In addition the kWh value reported for row "Retail Transmission Rate - Line and Transformation Connection Service Rate" was 331,606,198 kWh and this value should be adjusted to 331,492,483 kWh as well, so the value reported for the Distributed Generation [gen] Service Classification of 113,715 kWh is not double-counted.
