Union Gas Limited

Application for approval to expropriate certain interests in lands in the City of Hamilton, the City of Burlington and the Town of Milton.

PROCEDURAL ORDER NO. 1 September 18, 2015

Union Gas Limited (Union) applied on July 20, 2015 to the Ontario Energy Board (OEB) for authority to expropriate certain interests in lands required for the construction of a natural gas pipeline and ancillary facilities in the City of Hamilton, City of Burlington and Town of Milton.

A Notice was issued on August 18, 2015 and was served and published as directed.

The OEB did not receive any application for intervenor status.

I consider it necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

- 1. If OEB staff requires information and material from Union that is in addition to Union's evidence and that is relevant to the hearing, OEB staff shall request it by written interrogatories delivered to Union and filed with the OEB by October 1, 2015.
- 2. Union shall file with the OEB complete responses to the interrogatories by **October 15, 2015**.
- 3. Unless the OEB orders otherwise, OEB staff may file any written submission with the OEB and deliver it to Union by **October 29, 2015**.

4. Unless the OEB orders otherwise, Union may file a written reply submission with the OEB by **November 12, 2015**.

All filings to the Board must quote the file number, EB-2015-0230 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at https://www.pes.ontarioenergyboard.ca/eservice/. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. If the web portal is not available parties may email their documents to the address below.
