Ontario Producers and Storage Companies ("OPSC") APPLICATION FOR INTERVENOR STATUS

- 1. OPSC requests intervenor status in the proceeding for adjudication of the Application.
- 2. OPSC is a group of companies affiliated and working together, which are incorporated in Alberta and in Ontario, which carry on the business of natural gas production and storage development in Ontario, almost exclusively in the areas services by transmission and distribution of natural gas by Union Gas Limited ("Union").
- 3. Together, the OPSC group of companies represents the second largest producer group of oil and natural gas in Ontario, producing approximately 400 BOE daily.
- 3. With the exception of Tribute Resources Inc., which is a publicly traded Canadian company, the OPSC group is comprised of Canadian-controlled private corporations.
- 4. The OPSC group of companies produces natural gas in southern Ontario and primarily delivers gas into Union's OEB-regulated system.
- 5. OPSC has an interest in matters involving Union's system facilities, costs, rates and policies and any effect they may have on the services, plans and operations provided by the OPSC group of companies.

- 6. OPSC reserves its rights to participate in all aspects of the proceeding, including evidence, interrogatories, cross-examination and argument.
