RE: Application for an Amendment to Schedule 1 TransCanada Energy Ltd. Generator Licence (EG-2009-0024)

TransCanada Energy Ltd. ("TCE") is seeking an amendment to Schedule 1 of its electricity generator's licence numbered EG-2009-0024. TCE requests that the amendment be processed on an expedited basis given that the transactions underlying the amendment application are expected to be completed effective November 30, 2015.

Reason for Amendment

By way of the applicable, and respective, share transfer agreements, TCE has acquired all of the issued and outstanding share capital in and to the following entities:

- 2225256 Ontario Inc.;
- 2225342 Ontario Inc.;
- 2225345 Ontario Inc.;
- 2225213 Ontario Inc.; and
- Tempest Power Corp. (collectively "the Companies)

whereby such Companies own the following facilities, respectively:

- Liskeard 1 ("LK1") solar facility;
- Liskeard 3 ("LK3") solar facility;
- Liskeard 4 ("LK4") solar facility;
- Mississippi Mills ("MM") solar facility; and
- William Rutley ("WR") solar facility (collectively "the Facilities" or "the Assets")

Effective as of November 30, 2015, all of the Assets will be transferred and conveyed to TCE and the Companies shall be wound-up and dissolved. As such, TCE will require that the Facilities be added to its list of licensed generation facilities under Schedule 1 of license EG-2009-0024.

Request to Dispose without a Hearing

TCE requests that this proceeding be disposed of without a hearing as outlined in section 21(4)(b) of the *Ontario Energy Board Act*, 1998. Section 21(4)(b) of the Ontario Energy Board Act states that the Board may dispose of a proceeding provided that:

"...no person, other than the applicant, appellant or licence holder will be adversely affected in any material way by the outcome of the proceedings and the applicant, appellant or licence holder has consented to disposing of a proceeding without a hearing."

It is TCE's position that that the outcome of this proceeding will not adversely affect any person, including the applicant and the licence holder, since they are both subsidiaries of the same company and the amendment to the licence is an administrative change, rather than a substantive change. TCE consents to disposing of this proceeding without a hearing for itself, and on behalf of the Companies. TCE submits that the licence amendment being requested is specific and limited to a transfer of ownership with no material impacts to the operations of the Facilities and therefore, no material impacts to the electric system or consumers.
