Appendix A – Transmission Lines for Hydro One Networks Inc. and Schedule A for Five Nations Energy Inc. have been revised to show the sale and transfer of part of M3K Transmission Line from Moosonee Switching Station for 80 kilometres Northwest along James Bay from Hydro One Networks Inc. to Five Nations Energy Inc.

The Multi-Site Land Use Permit (LUP) refers to an Appendix A, also known as Schedule A which outlines the area and location of hydro transmission lines each company has on Crown land. The LUP documents were not revised to reflect this transfer but the respective Appendix A for each company was revised to account for this transfer between the two companies.

The Appendix A for Five Nations was revised to reflect the additional area for the 80 kilometre transmission line.

The Appendix A for transmission lines for Hydro One Network Inc. was revised to reflect the reduction in area for the 80 kilometre transmission line.

Since the date for completion of the sale of this transmission line has not been finalized and our changeover of our financial system requires the total annual rent for each company to be finalized by October 2, 2015, the 2016 annual rent for each company will be adjusted to reflect this transfer. The adjusted annual rent for each company will be effective January 1, 2016.
