The Ontario Energy Board (OEB) has now issued its Notice of Hearing for Centre Wellington Hydro's 2016 incentive regulation mechanism application (Notice). Vulnerable Energy Consumers Coalition (VECC).

2. If Centre Wellington Hydro is a Host Distributor, to no later than the date the Notice is posted on Centre Wellington Hydro's website in accordance with paragraph 3, serve a copy of the enclosed enclosed Notice directly on its Embedded Distributor(s).

3. To make a copy of the Notice, the application and evidence, and any amendments thereto, available for public review at Centre Wellington Hydro's office and in a prominent place on Centre Wellington Hydro's website.
4. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 1 through 3 above immediately thereafter.
5. To provide a copy of the Notice, application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
