**Application for electricity distribution rates and other  
charges effective January 1, 2016**

**PROCEDURAL ORDER NO. 2**

**October 22, 2015**

Horizon Utilities Corporation (Horizon) filed a complete application with the Ontario Energy Board (OEB) on August 12, 2015 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B) and under the OEB's Filing Requirements for Incentive Regulation Rate Applications seeking approval for changes to its electricity distribution rates to be effective January 1, 2016. On August 27, 2015 Horizon filed an amendment to its application correcting Appendix C to the application.

The OEB issued a Notice of Hearing on September 17, 2015 and Procedural Order No. 1 on October 7, 2015.

Late intervention requests were received from the School Energy Coalition (SEC) on October 13, 2015 and from the City of Hamilton (City) on October 20, 2015. No objection was received to either request. SEC's late intervention request was granted in a letter dated October 20, 2015. I hereby grant intervenor status to the City on the condition that the City must accept the record of the proceeding as it currently stands.

An updated list of parties in this proceeding is attached as Schedule A to this procedural order.

Parties are reminded to consult sections 26 and 27 of the OEB's *Rules of Practice and Procedure* (as revised April 24, 2014) regarding required naming and numbering conventions and other matters related to interrogatories.

I consider it necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.
