# ONTARIO ENERGY BOARD NOTICE TO CUSTOMERS OF ENERSOURCE HYDRO MISSISSAUGA INC.

# Enersource Hydro Mississauga Inc. has applied to raise the rates it charges for the distribution of electricity.

Enersource Hydro Mississauga Inc. has applied to the Ontario Energy Board to increase the amount it charges for distributing electricity by approximately \$1.09 each month for a typical residential customer that uses 800 kWh of electricity per month starting on January 1, 2016. Other customers, including businesses, may be affected as well.

The requested rate change includes an adjustment using a formula which is tied to inflation and other factors intended to promote efficiency.

The application also includes Enersource Hydro Mississauga Inc.'s request to raise its rates to finance previously installed high voltage system investments and replace end of life equipment. The application also includes a request to recover costs related to the connection of renewable generation.

### THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider Enersource's request. We will determine whether Enersource has used the applicable models and formulas as required by the OEB and whether to approve Enersource's request for incremental funding and funding to connect renewables. At the end of this hearing, the OEB will decide on the appropriate rate changes.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

#### **BE INFORMED AND HAVE YOUR SAY**

You have the right to information regarding this application and to be involved in the process:

- You can review Enersource's application on the OEB's website now.
- You can file a letter with your comments, which will be considered during the hearing.
- You can become an active participant (called an intervenor). Apply no later than **November 16, 2015** or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- At the end of the process, you can review the OEB's decision and its reasons on our website.

The OEB intends to consider cost awards in this proceeding that are in accordance with the *Practice Direction* on *Cost Awards* and are in relation to Enersource's proposed request for incremental capital funding and funding to connect renewables.

These proposed charges relate to Enersource's distribution services. They make up part of the Delivery line - one of the five line items on your bill. There are two types of OEB hearings – oral and written. Enersource has applied for a written hearing. The OEB is considering this request. If you think an oral hearing is needed, you can write to the OEB to explain why by **November 16, 2015.** 

#### PRIVACY

If you write a letter of comment, your name and the content of your letter or the documents you file with the OEB will be put on the public record and the OEB website. However, your personal telephone number, home address and email address will be removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.

This rate hearing will be held under section 78 of the Ontario Energy Board Act, 1998, S.O. 1998 c.15 (Schedule B).
