

ONTARIO ENERGY BOARD NOTICE TO CUSTOMERS OF ORILLIA POWER DISTRIBUTION CORPORATION

Orillia Power Distribution Corporation has applied to lower its electricity distribution rates.

Orillia Power Distribution Corporation has applied to the Ontario Energy Board to dispose of the balance in an account which, if approved, would result in a decrease the amount it charges a typical residential customer by approximately \$1.82 each month for a two-year period beginning on January 1, 2016. Other customers, including businesses, may be affected as well.

THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider Orillia Power's request. We will question the company on its case. We will also hear arguments from individuals and from groups that represent Orillia Power's customers. At the end of this hearing, the OEB will decide on the appropriate rate changes.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- You can review Orillia Power's application on the OEB's website now;
- You can file a letter with your comments, which will be considered during the hearing;
- You can become an active participant (called an intervenor). Apply no later than **[insert date 10 calendar days from publication]** or the hearing will go ahead without you and you will not receive any further notice of the proceeding;
- At the end of the process, you can review the OEB's decision and its reasons on our website.

The OEB intends to consider cost awards in this proceeding that are in accordance with the *Practice Direction on Cost Awards* and are in relation to Orillia Power's proposed clearance of the balance in Deferral Account 1576 of \$1,481,013 as at December 31, 2014 as a refund to customers over a two year term.

WRITTEN HEARING

There are two types of OEB hearings – oral and written. The OEB is considering holding a written hearing in this case. If you think an oral hearing is needed, you can write to the OEB to explain why by **[insert date 10 calendar days from publication]**.

PRIVACY

If you write a letter of comment, your name and the content of your letter or the documents you file with the OEB will be put on the public record and the OEB website. However, your personal telephone number, home address and email address will be removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.

This rate hearing will be held under section 78 of the Ontario Energy Board Act, 1998, S.O. 1998 c. 15 (Schedule B).
