Horizon Utilities Corporation

**Application for electricity distribution rates and other
charges effective January 1, 2016**

PROCEDURAL ORDER NO. 3

November 9, 2015

Horizon Utilities Corporation (Horizon) filed a complete application with the Ontario Energy Board (OEB) on August 12, 2015 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B) and under the OEB's Filing Requirements for Incentive Regulation Rate Applications seeking approval for changes to its electricity distribution rates to be effective January 1, 2016. On August 27, 2015 Horizon filed an amendment to its application correcting Appendix C to the application.

The OEB issued a Notice of Hearing on September 17, 2015 and Procedural Order No. 1 on October 7, 2015. Procedural Order No. 2 was issued on October 22, 2015 and a non-transcribed technical conference was held on October 23, 2015. On November 5, 2015, Horizon informed the OEB that it was withdrawing the request for a deferral account for the costs associated with the implementation of monthly billing for all customers. Horizon filed its responses to undertakings from the technical conference (not including those that were no longer relevant following the withdrawal of the request for a deferral account for monthly billing) on November 6, 2015.

In response to a request from an intervenor, the Board has revised the due dates for submissions.

IT IS THEREFORE ORDERED THAT:

1. Any written submissions by OEB staff and intervenors shall be filed with the OEB and delivered to all other parties by **November 16, 2015**.
2. Horizon may file a written reply submission with the OEB, and deliver it to intervenors by **November 23, 2015**.

All filings to the OEB must quote the file number, EB-2015-0075 and be made electronically in searchable/unrestricted PDF format through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.

All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
