**Board File No. EB-2015-03040 Ontario Energy Board Consultation
Review of Miscellaneous Rates and Charges
Energy Probe – Notice of Interest in Participation**

Pursuant to the Letter from the Board on November 5, 2015, outlining the consultation process by which the Board will conduct a comprehensive Review of Miscellaneous Rates and Charges, Energy Probe Research Foundation (Energy Probe) is hereby providing its Notice of Interest in Participation in the EB-2015-0304 consultation for the Board's consideration.

As a first step, Energy Probe wishes to nominate Larry Schwartz to participate in the Pole Attachments Working Group (PAWG). Energy Probe would like to draw to the attention of the Board that it has participated in a number of proceedings before the Board that dealt with disputed rates for pole attachments. In RP-2003-0249, during the Motions Day Hearing, the Panel Chair noted:

To the Board costs, we will add the costs of the expert evidence that has been prepared jointly by the CEA and the EDA, and we will add the costs of Energy Probe. We recognize that based on an earlier decision, expenditures were incurred with respect to that expert evidence. We also realize that Energy Probe is a non-commercial entity, and perhaps of all the parties is more aligned to what might be regarded as a consumer interest or the public interest. That's the reason we have dealt with their costs differently.
(Transcript, Volume Motions Day, Para 645)

More recently, Energy Probe took a leading role in EB-2013-0234, an Application by Toronto Hydro, for an order, pursuant to section 29 of the *Ontario Energy Board Act, 1998* (the "Act"), that the Board refrain from regulating the terms, conditions and rates for the attachment of wireless telecommunications devices ("wireless attachments") to THESL's utility poles. Dr. Schwartz acted as economic consultant to Energy Probe in that matter.

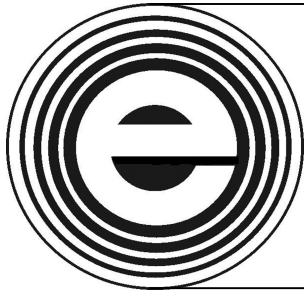
