Re: Application for Amendment to Electricity Generation Licence - Name

Change

RayLight LP (EG-2013-0364)

We are counsel for RayLight LP (the "Partnership") and its partners. The Partnership is seeking an amendment to its Electricity Generation Licence numbered EG-2013-0364 (the "Licence") to change the name listed on the Licence to reflect the conversion of the partnership from a limited partnership to a general partnership.

Reason for Amendment

The partners of the Partnership intend to enter into an amended and restated partnership agreement to convert the limited partnership to a general partnership. Following the conversion, the Partnership will be named Concord RayLight Partnership.

Description of the Amendment

The Partnership requests that the name listed on the Licence be amended to Concord RayLight Partnership.

Request to Dispose without a Hearing

We request that this proceeding be disposed of without a hearing as outlined in section 21(4)(b) of the *Ontario Energy Board Act*, 1998. Section 21(4)(b) states that the Board may dispose of a proceeding provided that:

no person, other than the applicant, appellant or licence holder will be adversely affected in a material way by the outcome of the proceeding and the applicant, appellant or licence holder has consented to disposing of a proceeding without a hearing.

The outcome of this proceeding will not adversely affect any person, including the applicant and Licence holder, since the amendment to the Licence is an administrative change, rather than a substantive change. The Partnership consents to disposing of this proceeding without a hearing. The requested amendment poses no material impact to the electrical system or customers.
