We are counsel for MightySolar LP (the "Partnership") and its partners. The Partnership is seeking an amendment to its Electricity Generation Licence numbered EG-2013-0199 (the "Licence") to change the name listed on the Licence to reflect the conversion of the partnership from a limited partnership to a general partnership.
