We are counsel for CSI Val Caron LP (the "Partnership") and its partners. The Partnership is seeking an amendment to its Electricity Generation Licence numbered EG-2013-0220 (the "Licence") to change the name listed on the Licence to reflect the conversion of the partnership from a limited partnership to a general partnership.

### **Reason for Amendment**

The partners of the Partnership intend to enter into an amended and restated partnership agreement to convert the limited partnership to a general partnership. Following the conversion, the Partnership will be named Concord Val Caron Partnership.
