Enersource Hydro Mississauga Inc.

**Application for electricity distribution rates and other
charges effective January 1, 2016**

PROCEDURAL ORDER NO. 2

December 15, 2015

Enersource Hydro Mississauga Inc. (Enersource) filed a complete application with the Ontario Energy Board (OEB) on October 2, 2015 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B) and under the OEB's Filing Requirements for Incentive Regulation Rate Applications seeking approval for changes to its electricity distribution rates to be effective January 1, 2016.

The OEB issued an Order for Interim Rates and Procedural Order No. 1 on November 17, 2015. OEB staff and intervenors requested further information which Enersource provided on December 9, 2015. The OEB has determined that there is a requirement for OEB staff and intervenors to ask further questions of Enersource.

The Board considers it necessary to make provision for the following matters related to this proceeding.

THE ONTARIO ENERGY BOARD ORDERS THAT:

1. A technical conference will be held **January 8, 2016** starting at 9:30 a.m. in the OEB's Offices at 2300 Yonge Street, 25th floor, Toronto, Ontario to respond to questions by OEB staff and intervenors. By no later than **December 22, 2015**, OEB staff and intervenors shall file with the OEB, a list of the issues they would like to discuss and provide specific questions where

it would assist the applicant in providing timely and accurate responses.

2. Any undertakings shall be filed with the OEB no later than **January 18, 2016**.
3. Any written submission by OEB staff and intervenors shall be filed with the OEB and delivered to all other parties by **January 25, 2016**.
4. Enersource may file a written reply submission with the OEB, and deliver it to intervenors by **February 1, 2016**.

All filings to the OEB must quote the file number, EB-2015-0065 and be made electronically in searchable/unrestricted PDF format through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.

All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
