Union Gas Limited

Application for leave to construct a natural gas pipeline and ancillary facilities in the Town of Milton and the Town of Oakville and for approval to recover the cost consequences of the development of the proposed Burlington Oakville Project.

PROCEDURAL ORDER NO. 7

December 21, 2015

Union Gas Limited (Union) filed an application with the Ontario Energy Board (OEB) on December 12, 2014 to construct a pipeline and ancillary facilities in the Town of Milton and the Town of Oakville (Burlington Oakville Project or Project) and for approval to recover the costs of the development of the Project.

On December 17, 2015 the OEB issued a Decision and Order approving the Project and setting the schedule for cost award procedure. On December 18, 2015 the Canadian Manufacturers and Exporters (CME) asked for an extension of the cost claim filing date due to office closing during the holiday season, from December 29, 2015 to January 4, 2016 (extension request). The CME noted that it communicated the extension request to Union and that Union has no objection to the extension.

The OEB finds the CME extension request reasonable. The OEB grants the extension request to CME and all other participants that are eligible for cost awards. By way of this Procedural Order the OEB will adjust the cost award process timeline for all participants. The timeline set in the Decision and Order dated December 17, 2015 is no longer in effect.

The OEB considers it necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

THE OEB ORDERS THAT:

1. A decision regarding cost awards will be issued at a later date. Intervenor shall file with the OEB and forward to Union their respective cost claims by **January 4, 2016**. Cost claims must be prepared in accordance with the OEB's Practice Direction on Cost Awards.
2. Union will have until **January 14, 2016** to object to any aspect of the cost claims. A copy of the objection must be filed with the OEB and one copy must be served on the party against whose claim the objection is being made.
3. Any party whose cost claim was objected to will have until **January 25, 2016** to make a reply submission as to why the cost claim should be allowed. One copy of the submission must be filed with the OEB and one copy is to be served on Union.

All filings to the OEB must quote file number **EB-2014-0182**, be made through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format.

Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.ontarioenergyboard.ca. If the web portal is not available you may email your document to the BoardSec@ontarioenergyboard.ca. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file seven paper copies. If you have submitted through the OEB's web portal an e-mail is not required.
