Tillsonburg Hydro Inc.

**Application for electricity distribution rates and other
charges effective May 1, 2016.**

**PROCEDURAL ORDER NO. 1
December 22, 2015**

Tillsonburg Hydro Inc. (Tillsonburg Hydro) filed a complete application with the Ontario Energy Board (OEB) on November 2, 2015 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B) and under the OEB's Filing Requirements for Incentive Regulation Rate Applications seeking approval for changes to its electricity distribution rates to be effective May 1, 2016.

The OEB issued a Notice of Hearing on December 3, 2015. Vulnerable Energy Consumers Coalition (VECC) applied for intervenor status and cost eligibility in relation to Tillsonburg Hydro's proposal for mitigating the impact of the shift to fixed rates. No objection was received.

I approve VECC as an intervenor and have determined that VECC is eligible to apply for an award of costs under the OEB's *Practice Direction on Cost Awards* in relation to Tillsonburg Hydro's request outlined above.

The list of parties in this proceeding is attached as Schedule A to this procedural order.

Parties are reminded to consult sections 26 and 27 of the OEB's *Rules of Practice and Procedure* (as revised April 24, 2014) regarding required naming and numbering conventions and other matters related to interrogatories.

I consider it necessary to make provision for the following matters related to this proceeding. I am making provision for written submissions following the filing of

interrogatory responses, unless the OEB orders otherwise during the course of the proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

1. OEB staff and VECC shall request any information and material from Tillsonburg Hydro that is in addition to Tillsonburg Hydro's evidence and that is relevant to the hearing by written interrogatories filed with the OEB and delivered to Tillsonbrug Hydro by **January 7, 2016**.
2. Tillsonburg Hydro shall file with the OEB complete written responses to the interrogatories and deliver them to VECC by **January 21, 2016**.
3. Unless the OEB orders otherwise, any written submission by OEB staff and VECC shall be filed with the OEB and delivered to all other parties by **February 4, 2016**.
4. Unless the OEB orders otherwise, Tillsonburg Hydro may file a written reply submission with the OEB, and deliver it to VECC by **February 18, 2016**.

All filings to the OEB must quote the file number, EB-2015- 0104 and be made electronically in searchable/unrestricted PDF format through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.

All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
