The OEB issued a Decision and Final Rate Order in the above-noted proceedings on December 10, 2015. The Decision and the Final Rate Order each contained typographical errors. Today, the OEB is reissuing the Decision and the Final Rate Order, with the typographical errors corrected.

The first correction can be found on page 8 of the Decision, in the Group 1 Deferral and Variance Account Balances table:

Applicable only for Non-Wholesale Market Participants

In the Final Rate Order as originally issued, the fourth line read:

Applicable only for Non-Wholesale Market Participants
