Re: EB-2015-0114 - Enbridge Gas Distribution Inc. (EGD) 2016 Rate Adjustment Application.

Industrial Gas Users Association (IGUA) Statement of Costs.

We are in receipt of EGD's letter of January 14th commenting on cost claims for the captioned proceeding.

In respect of IGUA's cost claim, EGD did not take objection, but pointed out that the Statement of Costs allocated 1.7 hours to preparation of argument. Of course, there was no argument phase in this proceeding. EGD is correct that the subject time should have been allocated to a different category.

That time was really spent on overall preparation for participation in the application (see docket entries dated October 6, 7, 19, 21) rather than any particular phase of the process, save for a small time entry for December 10th involving review of the Board's decision.
