**Enbridge Gas Distribution Inc. has applied for approval to dispose of certain account balances.**

**Enbridge Gas Distribution Inc. has applied to the Ontario Energy Board for approval to dispose of amounts recorded in certain deferral or variance accounts related to the delivery of conservation programs in 2014 which it says will increase the total bill of a typical residential customer that consumes an annual volume of 3,064 m<sup>3</sup> of natural gas by approximately \$7.00 per year.**

**Other customers, including businesses, may also be affected.**

### **THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING**

The OEB will hold a public hearing to consider Enbridge's request. We will question the company on its case. ## APPLICATION

1. Enbridge Gas Distribution Inc. ("Enbridge" or the "Company") is an Ontario corporation with its head office in the City of Toronto. It carries on the business of selling, distributing, transmitting and storing natural gas within Ontario. The Company also undertakes Demand Side Management ("DSM") activities.
2. Enbridge hereby applies to the Ontario Energy Board (the "OEB" or the "Board"), pursuant to section 36 of the *Ontario Energy Board Act, 1998*, as amended (the "Act"), for an Order or Orders approving the final balances in the following 2014 DSM accounts and the disposition of these balances:

DSM Incentive Deferral Account ("DSMIDA")	\$7,647,242
LRAM Variance Account (Reimbursable to Ratepayers)	(\$65,339)
DSMVA Amount	\$352,502
Total Amount Recoverable	\$7,934,405

3. Enbridge applies to the Board for such final and interim orders and/or accounting orders as may be necessary in relation to the clearance of the accounts which are the subject of this Application, within the next available QRAM following the Board's approval. The Company further applies to the Board pursuant to the provisions of the Act and the Board's *Rules of Practice and Procedure* for such final and interim Orders and directions as may be necessary in relation to this Application and the proper conduct of this proceeding.
4. The persons affected by this Application are the customers of Enbridge. It is impractical to set out the names and addresses of the customers because they are too numerous.
